Subject : Discontinuation of Options in Goods Contracts on Maize, Guar Complex (Guar seed and Guar gum) and Spices Complex (Dhaniya, Jeera and Turmeric) – Non availability of further expiries from February 2024

In terms of Exchange Circular no. NCDEX/TRADING-96/2016/232 dated September 22, 2016, on Permission for trading in futures contracts and modification in contract specifications at exchange level, the members are hereby informed that the Exchange will not be launching further contracts of the Options in Goods contract in Maize , Guar Complex (Guar seed and Guar gum) and Spices (Dhaniya, Jeera, and Turmeric) i.e., no further expiries will be launched post January 2024 (i.e., expiries due to be launched on February 02, 2024 and thereafter will not be launched).
